


SEBERT WOOD - COVID 19 HOME SCHOOL AGREEMENT – MARCH 2021



SEBERT WOOD PRIMARY SCHOOL AGREES TO:

- Provide an environment which has been risk assessed in response to COVID-19.
- Follow guidance as set out by the government, as much as we reasonably can.
- Provide a curriculum that meets your child's well-being, mental health and academic needs.
- Contact you immediately if your child displays symptoms of COVID-19 in school.
- Inform you if staff or children in your child's 'bubble' tests positive for COVID-19 as this will mean that all children in the 'bubble' will need to self-isolate for at least 10 days.
- Communicate between home and school through email, phone and the school website.
- Follow government cleaning and hygiene guidance.

PARENT/CARER AGREES TO: *help my child at school and I know and understand that:*

- I will explain to my child about the changes to school put in place and that all staff instructions must be followed.
- If my child, or anyone in my household, shows symptoms of COVID-19, I will not send them to school, we will self-isolate for 10 days as a family, I will arrange tests and inform the school as soon as possible.
- I will take responsibility for my child when entering and moving around the school site and I agree to follow all appropriate measures.
- On my way to school and when dropping/collecting my child, I will adhere to social distancing rules of a distance of 1 metre or more.
- If my child shows symptoms of COVID-19 at school, I will collect my child from school immediately.
- I will strictly adhere to the specific school timings for my child.
- My child will only bring necessary items into school (*for essential medication/sanitary items please notify the school office*)
- I will report to the school if my child is unwell or has a temperature and keep them at home to monitor the symptoms. I will keep the school updated.
- I will explain to my child that they will need to use good respiratory and hand hygiene.
- I will not be allowed into the school building.
- I will support all staff in their efforts to create a 'safe as possible' environment.
- I will read all updates/emails that are sent home.
- I will inform the school of any changes in circumstances, or if our emergency contact details change.
- If my child is deemed 'unsafe' as they are not following the COVID-19 measures put in place, they may be subject to a fixed term exclusion in line with the behaviour policy.

PUPIL AGREES TO: *know and understand that:*

- I will follow the school rules in class, around school and in the playground.
- I will stay in my 'bubble' and not mix with children in other bubbles.
- I will follow good hygiene rules:
 - Coughing and sneezing into elbow or tissue (*catch it-bin it-kill it*)
 - Wash my hands with soap and water for 20 seconds
 - Avoid touching my mouth, nose and eyes with my hands.
- I will tell an adult immediately if I feel unwell.
- I will only bring the things I am allowed to bring to school and use the equipment provided to me by school.
- I will only use the toilet facilities I am told to use.
- I will only come in and out of school through the gate I have been told to.
- I will stick carefully to my zone on the playground and field.
- I will behave in a way that keeps myself and everyone safe.
- I will follow these rules and know that if I don't, I can be sent home.
